Applications should attach a letter with the application detailing:

1. Dates of visit to the island
2. The date you plan to pick up your marriage license

If either party is divorced, a certified copy of the divorce decree must accompany the application. If former partner is deceased, a certified copy of the death certificate must accompany the application. Either a money order or a certified cashier's check for \$100 made out to the Superior Court must accompany the application (\$50 for application and \$50 for the license). The Superior Court must receive your marriage license application eight (8) days prior to issuing your license. The couple must pick up their marriage license in person from Superior Court, with a form of photo identification. The Superior Court is located in the Alexander Farrelly Justice Complex on the waterfront in Charlotte Amalie, St. Thomas (Federal Building). The court is open 8:30 am -5 pm, Monday through Friday, & Saturday's 10 am -12 noon.

Helpful Hint: Two weeks after mailing your application, phone Ms. Lockhart to confirm that the court has received the application and to verify when you will pick up your license.
